All content appearing on the Financial Poise™ family of websites is copyrighted. The following guidelines should be followed for reprinting or sharing any content on our sites:

Linking to our websites:

Anyone is free to link to any of our websites, or pages on our websites, however, we do **not** allow you to post any of our content or publications on your website without permission, with the exception of fair use.

Content contributors may share a brief excerpt or summary (100 words or less not including title) of content they contributed personally on their personal and company websites, and on social media, but they must include a backlink* to the original article with the excerpt or summary.

Sharing Our Content:

Icons for sharing content through email and social media are included with all content on the Financial Poise sites. You are free to share content via email or social media with these links at any time and in any case where they exist.

Republication of Content by Authors/Companies:

Financial Poise only allows full republication of content by the original author and/or their employer, and only with permission. Authors may republish content in accordance with the following options after they have received written permission:

- In PDF form on the author's or company's website
- As a republication directly on the author's or company's website
- In print form for distribution by the author or company
- In e-print form for email distribution by the author or company

Any republication must include a backlink* to the original piece of content.

Republication for Non-Profits:

If you are a non-profit entity and would like to use our material for educational purposes, it may be possible for you to do so without charge. Please contact us directly, as requests of this nature are approved on a case-by-case basis. A backlink* to our original work must be included, should this option be approved.

Any content that is redistributed in paper form or in a written publication must include the following statement:

Pricing Options for Republication:

In PDF form on the author’s or company’s website: \$275

As a republication directly on the author’s or company’s website \$275

In print form for distribution by the author or company \$275

In e-print form for email distribution by the author or company \$275

You can choose any 3 options for \$725 and all 4 for \$800

***Please note:** you cannot use “nofollow” links to link to our original work if you republish it in any capacity. Avoiding this will alleviate problems with SEO on both of our sites.

Altering Content:

You may not alter the text or images of any of our content without our express authorization.

Use of Images:

Financial Poise holds a license to use the images and graphic elements used in our content. You may not reproduce any images from our content, even if permission is granted to republish content containing an image. If you want images in your republished content, you will need to acquire images on your own and present them to Financial Poise for approval to add them to the content.

Quoting Content:

Under certain circumstances, it is permissible to make direct quotes from content found on the Financial Poise family of sites. You may not quote from content, or combine quotes, in a manner that changes their meaning. This includes mixing quotes to form different sentences and taking quotes out of context in a manner that obscures their intended meaning. If a large section of content is comprised of quotes from our content, it may be considered infringement. If you are unsure if this is an issue in your case, it is best to submit a request.
